

Dear Parents/Guardians,

We are pleased to announce our 28th Annual Performances will be held at Stevenson High School's Performing Arts Center on Saturday June 6, and Sunday June 7, 2026!

The performances are open and optional for all of our students and are always a highlight! Performances are separated by classes* and ages. (*Leaps & Turns, Dance Team Technique and Pointe 1 are non-recital classes) Performance class listings will be emailed to all participating families mid- March. If your family has a known conflict on the performance days, please let us know. We will do our best to accommodate requests. Dress rehearsals will be held on Thursday, June 4 and Friday, June 5 at Stevenson High School. Times are TBD. Tickets (\$20 each) are sold through a 3rd party lottery system. Ticket forms are emailed to all families in April.

If you would like your child to participate we must receive this signed permission slip, \$40 accessory deposit per student and the participation fee (see below) on or before Saturday, December 13. If your child is participating in the performances, there is a \$40 accessory fee per class. Accessory fee balances are due no later than Thursday, January 15, 2026. All accessories will be worn with standard dress code or teacher recommendation for each class. If we do not receive the signed permission slip and fees by December 13, we will assume that your child is not participating in the June Performances. **We must receive a signed permission slip for each student, even if they are not performing-** please see below.

All performances will be professionally filmed & edited by Marston McCoy Media & photographed by Brandon Dahlquist Photography. **A \$125 recital participation fee will be charged per student & \$100 for each additional student per family.** The recital participation fee covers all digital download links for all performances and photos, programs, staffing for all open dress rehearsals and performances and Stevenson staff, security and technical elements at Stevenson High School's Performing Arts Center.
